BELARUS: AUTHORITIES SHOULD IMMEDIATELY RELEASE DETAINED HUMAN RIGHTS DEFENDER LEANID SUDALENKA

Statement by members of the Civic Solidarity Platform

22 January 2021

We, the undersigned organisations, members of the Civic Solidarity Platform, express our indignation about the <u>detention of Belarusian human rights defender</u> Leanid Sudalenka, head of the Human Rights Center Viasna branch in Homiel, and demand his immediate release and dropping of all charges against him.

Leanid Sudalenka is a prominent human rights defender, who primarily works on documenting human rights violations and has helped Belarusian citizens to prepare over 80 individual complaints to the UN Human Rights Committee. Leanid Sudalenka is a recipient of the 2018 "Liberty, Equality, Fraternity" Human Rights Prize of the French Republic. In 2019, he received the National Human Rights Award for achievements in the area of human rights work.

On 18 January, Leanid Sudalenka was detained and taken to the Investigative Committee's city office for questioning. He is detained as part of a criminal case under Art. 342 of the Criminal Code of the Republic of Belarus ("Organization and preparation of actions that grossly violate public order, or active participation in them"). Sudalenka's status in the case, however, remains unknown.

This detention was preceded by <u>persistent harassment</u> of Mr. Sudalenka by Belarusian authorities. On 5 January 2021, his office was searched by the officers of the Main Department for Combating Organized Crime and Corruption of the Ministry of Internal Affairs. The search lasted for about 10 hours, and the officials confiscated 304 items, including Leanid Sudalenka's laptop and bank cards. The officers also seized documents related to administrative cases and complaints of protesters as well as white-red-white flags of independent Belarus which are used as symbols of protests. The same evening, another search was conducted in his apartment.

After the search in the office, Leanid Sudalenka was taken to the Office for Combating Organized Crime for an interrogation as a witness in the criminal case. However, Sudalenka noted that during the interrogation he was asked about his legal and other assistance to people who had been detained, fined and arrested during the post-electoral protests in Homiel. In addition, during the search, the officials predominantly inquired about information about his work, his data carriers and bank cards.

We express our strongest concern over the harassment and detention of Leanid Sudalenka which we perceive as retaliation for his peaceful and legitimate human rights work. Leanid Sudalenka has committed no crime and there are no grounds for his prosecution. The actions of Belarusian authorities constitute a major breach of Belarus' obligations under international human rights law and OSCE commitments.

We demand that Belarusian authorities immediately and unconditionally release Leanid Sudalenka, drop all charges and stop the persecution against him. The authorities should also stop the persecution of other members of Human Rights Center Viasna, including Marfa Rabkova, Andrei Chapiuk, who are currently in detention centers, and all Belarusian human rights activists. The authorities should also guarantee that all human rights defenders in Belarus are able to carry out their legitimate human rights activities without fear of reprisals and free of all restrictions in all circumstances.

We urge OSCE executive and political bodies, institutions and participating States to take active public, diplomatic and other steps to ensure that Belarusian human rights defenders are immediately released and persecution against them is stopped. Continued large scale repression by the authorities of Belarus against human rights defenders, journalists, political opposition members, and participants of peaceful protests, as well as the ongoing torture and ill-treatment of detainees and suppression of all fundamental freedoms is intolerable. Stopping them and ending impunity for massive human rights abuse should be a primary subject of international action aimed at resolving the worst human rights crisis in Europe in the last two decades.
